The following terms and conditions relate to entry in the Chrysler Expo ["Expo 2009"] held by the Charger Club of WA Inc. ["the club"] on 8th February 2009 at Lathlain Park.

- 1 I, the undersigned, do hereby for myself, waive and release the club, its officers and all individual members thereof, and all other persons regardless of their capacity in any way connected with Expo 2009 from any and all right, claim or liability of any kind or nature that I might have. I do hereby acknowledge that this waiver and release will extend to any accidents, damages or claims arising out of my entry caused by my own acts caused by anyone outside my control. I further acknowledge and agree that I will be personally liable and accept full responsibility for any and all damage I, or any person within my control, may cause to the grounds upon which Expo 2009 is held or any equipment, vehicles, buildings, facilities or items used in connection with Expo 2009.
- 2 All vehicles must be in place by 9.00 am on Sunday 8th February 2009 and shall not be **started, leave or moved** from its designated position before 4.00pm. If your vehicle does need to be moved or leave early (only acceptable in the case of an emergency) you must approach a representative of the club to organise safe passage.
- 3 Vehicles entered for judging must allow the judges access to the engine bay and interior for judging. If your vehicle is unattended and locked when the judges come to view it, and they cannot access the required areas, the vehicle **will not be judged**. It is recommended that vehicles to be judged remain unlocked at all times.
- 4 Every effort is maintained to ensure that the judging system is fair, unbiased and transparent. The judges' decision is final and no correspondence will be entered into.
- 5 Cost of participation in Expo 2009 is \$20 per car judging or \$10 per car for display only **last entries for judged cars will be 31st January 2009**.
